What data do we collect?

IPSA collects the following data:

- Personal identification information (name, email address, phone number, address)
- Credit card information

How do we collect your data?

You directly provide IPSA with most of the data we collect. We collect data and process data when you:

- Complete membership information
- Register for a webinar, conference, or other service
- Voluntarily complete a member survey or provide feedback on any of our message boards or via email
- Provide payment for membership, conferences, or other services

How will we use your data?

The IPSA collects your data so we can:

- Process your order and manage your account

- Email you with membership information which includes IPSA business, membership renewal, and promotion of conferences and webinars

If you agree, IPSA will share your data with our sponsors so they may offer you their products and services.

IPSA does NOT disclose credit card account information provide by members and others. When members and others choose to pay using credit cards, IPSA submits the information needed to secure payment through the appropriate service provider.

How do we store your data?

IPSA securely stores your data via third-party membership management software. As of the date of this policy, Personify by Wild Apricot is the membership management software we use. Credit card information, if provided, is masked by Wild Apricot per industry standards.

Marketing

IPSA would like to send you information about products and services of ours, as well as those of event sponsors.

Members may opt out of receiving marketing emails when they create their profile. If you have agreed to receive marketing, you may always opt out at a later date from within your profile. You have the right at any time to ask IPSA to stop contacting you for marketing purposes or giving your data to our sponsors.

What are your data protection rights?

IPSA would like to make sure you are fully aware of all your data protection rights. Every use is entitled to the following:

- The right to access. You have a right to access your member profile to review the personal data you have provided.
- The right to rectification. You have the right to request that IPSA correct any information you believe is inaccurate if you are for some reason unable to do so within your member profile. You also have the right to request that IPSA complete information you believe is incomplete.
- The right to erasure. You have the right to request that IPSA erase your personal data under certain conditions.
- The right to restrict processing. You have the right to request that IPSA restrict the processing of your personal data under certain conditions.
- The right to object to processing. You have the right to object to IPSA's processing of your personal data under certain conditions.
- The right to data portability. You have the right to request that IPSA transfer the data we have collected to another organization, or directly to you, under certain conditions.

What are cookies?

Cookies are text files placed on your computer to collect standard internet log information and visitor behavior information. When you visit our websites, we may collect information from you automatically through cookies or similar technology.
